The stewards having heard the service park manager Karl Heinz Holz determined the following:

Fact: The responsibility of the persons found in breach of the service park safety measures in relation to Covid 19 could not be identified as team members or related to competitor #9


Decision: Cancellation of decision No3 (doc 2.4)



Fact: Team Support personnel not respecting Regulations mentioned in Bulletin No1 (COVID-19 Mitigation Plan)

Offence: Breach of 2021 FIA ISC Article 12.2.1h and 12.2.1.i

Decision: To levy a fine of 10.000 EUR

1000 Euro have to be paid to FIA according to 2021 FIA ISC 12.8.1


9000 EUR been suspended for the period of 2021 Middle East Rally Championship pending the competitor being reported for similar offences to the Stewards during leg 2 of Qatar International Rally 2021 or any Round in the 2021 Middle East Rally Championship

Reason: the competitor stated that his close family and friends were excited by his participation therefore he felt that were uncontrollable,


he acknowledged the fact that this behaviour is in breach of the safety measures and regulations
