**CHAMPIONSHIP GENERAL REGULATIONS / Art. 5 (Reminder)**

**5.1** Anyone wishing to take part in a round of 2024 QORC / cars must send the official entry form duly completed to the rally secretariat ([registration@qmmf.com.qa](mailto:registration@qmmf.com.qa)) before the date of entries closure. .

**5.2** An entry application will be accepted only if accompanied by the proof of payment of the entry fees which is **QR 800 per event**.

**5.3** Entry fees must be paid by bank transfer (see contacts/account no. in regulations)

The registration office must be notified by e-mail once a transaction is made through the bank.

**5.4** Any participant in a round of 2024 QORC / cars as defined in Article 4 (having passed administrative checks and scrutineering, regularly checked-in at TC1 - where applicable - and taken the start of the competitive element of that round) will be entitled to a **Start Prize** of

•**QR 1000**, if the entry has been received no later than 8 days before the date of scrutineering.

•**QR 800**, if the entry has been received no later than 96 hours before scrutineering.
